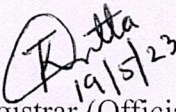

Proceedings of the 18th meeting of the Executive Council of the West Bengal State University, Barasat held on April 25, 2018 at 3.00 P.M. at West Bengal State University, Seminar Room, Administrative Block, New Building, Berunanpukuria, Malikapur, Barasat, Kolkata - 700126

The Hon'ble Vice Chancellor took the chair sharp at 3.00 P.M. and the meeting started with the welcome of the Executive Council members.

Agenda No. 1 : To place before the Executive Council for confirmation the minutes of the 17th Executive Council meeting held on 22.03.2018 at West Bengal State University, Seminar Room, Administrative Block, New Building, Berunanpukuria, Malikapur, Barasat, Kolkata - 700126

Resolution : Proceedings of the 17th meeting of the E. C. held on March 22, 2018 circulated amongst the members well in advance, were confirmed unanimously with the following modifications –

- 1) **Resolution to Agenda No. 2** – “The E.C. noted the letter no. 1318-Edn(U)/1U(WBSU) - 21/17 dated 30.11.2017 of Dy. Secretary to the Govt. of West Bengal, discussed and agreed to give effect to the date of promotion in term of 1197(28)-Edn(U) dt. 31.12.2012 to Dr. Narayan Ghorai **was modified as** “The E.C. noted the letter no. 1318-Edn(U)/1U(WBSU) -21/17 dated 30.11.2017 of Dy. Secretary to the Govt. of West Bengal, discussed and agreed to give effect to the date of promotion in term of 1197(28)-Edn(U) dt. 31.12.2012 for the case of promotion of Dr. Narayan Ghorai.
- 2) **Resolution to Agenda No. 28(xviii)** – “The appeal of the Student's Union, WBSU for allowing the PG students of the University to again re-appear in the Internal Assessment Exam, if absent was considered and discussed. The E.C. accepted the appeal and agreed to make necessary and appropriate changes to the regulation” **was modified as** “The appeal of the PG students, WBSU for allowing the PG students of the University to re-appear in the Internal Assessment Exam, if absent was considered and discussed. The E.C. accepted the appeal and agreed to make necessary and appropriate changes to the regulation.”

Agenda No. 2 : To place before the E.C. a matter of Confidential nature, related to the issue of Controller Of Examinations(Under Suspension)

Resolution : The following steps were taken to resolve the issue –

- a) E.C. considered all papers including the report of the enquiry submitted by the Enquiry Officer and representation of the Charged Officer.
- b) E.C. further considered the E-Mail communication received from the Charged Officer on 25.04.2018

- c) E.C. reluctantly accepts the resignation of the Charged Officer with effect from the afternoon of 25.04.2018.
- d) The period of suspension is confirmed and not to be considered in reckoning, and during the period of suspension the Charged Officer will not get any other allowance other than the subsistence allowance paid.
- e) E.C. advises the administration to clear all his dues as per rules.

Agenda No. 3 : Miscellaneous items of Academic nature, if any, with the permission of the Chair

Resolutions :

- i) The Minutes of the 1st meeting of the Finance Committee of Financial Year 2018 – 2019 held on 20.04.2018 at 3.00 P.M. at Annexure A was placed before the Executive Council for discussion. The Minutes of the meeting were noted and approved.
- ii) The proposal of the OSD-ADMIN, In-charge of the Office of the Controller of Examinations, WBSU and the corresponding resolutions are annexed at Annexure B.
- iii) The proposal of the Inspector of Colleges(Acting), WBSU and the corresponding resolutions are annexed at Annexure C.
- iv) The E.C. agreed to introduce the Choice Based Credit System for the UG Courses from the session 2018-19. The draft regulation of the CBCS has been prepared and is to be circulated to the colleges.
- v) The E.C. opined that CBCS is also to be introduced for PG Courses of the University and its affiliated Colleges.
- vi) The E.C. considered the draft MOU between Dr. Kaushik Roy, Professor, Dept. of Computer Science and REVE Systems LTD., a multinational software company and advised to obtain a legal opinion before pursuing the matter.
- vii) The proposal of Prof. Sipra Mukherjee, Dept. of English, WBSU vide letter dated 24.05.2018 for introduction of 2 foreign language courses in Korean and Communicative English was considered by the E.C. The E.C. agreed in principle to introduce the same.
- viii) The proposal of Dr. Abhijit Das, HOD, Dept. of Anthropology, WBSU vide letter dated 19.04.2018 for teaching Assistantship (without any remuneration or allowances) of Dr. Chitradip Bhattacharjee, ICSSR Post Doctoral fellow of the department was considered and the same was accepted by the E.C.

No. 274-L.—21st February, 2008.—The following Act of the West Bengal Legislature, having been assented to by the Governor, is hereby published for general information:—

West Bengal Act XXVIII of 2007

THE WEST BENGAL STATE UNIVERSITY
(BARASAT, NORTH 24 PARGANAS) ACT, 2007.

[Passed by the West Bengal Legislature.]

[Assent of the Governor was first published in the *Kolkata Gazette*,
Extraordinary, of the 25th February, 2008.]

An Act to provide for the establishment and incorporation of West Bengal State University (Barasat, North 24 Parganas) in the district of North 24 Parganas in the State of West Bengal and for certain matters incidental thereto and connected therewith.

WHEREAS it is expedient to establish and incorporate the West Bengal State University (Barasat, North 24 Parganas) in the district of North 24 Parganas in the State of West Bengal for encouraging and providing for instruction, teaching, training and research in various branches of learning and courses of study, promoting advancement and dissemination of knowledge and learning and extending higher education, and for meeting the growing needs of the society;

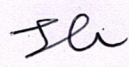

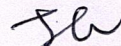
In exercise of the power conferred by sub-section(3) of section 5 of the West Bengal State University (Barasat, North 24-Parganas) (West Bengal Act XXVIII of 2007), the Governor is pleased hereby to appoint the 26th day of May, 2008 with effect from which such colleges existing within the limits of the district of North 24-Parganas in the State of West Bengal as specified in the schedule below shall be deemed to be affiliated to the West Bengal State University (Barasat, North 24-Parganas) and continue to be so affiliated until the University otherwise directs, and shall cease to be affiliated to the University of Calcutta or any other University to which they may have been affiliated before the said date subject to the conditions that the powers and jurisdiction exercised by the West Bengal University of Health Sciences and the West Bengal University of Technology shall not be affected by this Notification.

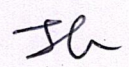
